This recipient guarantee fee is paid only one time for each donor mare, no matter how many embryos or oocytes the same mare/owner wishes to harvest and transfer from that same donor mare in 2022. If a different mare/owner wishes to harvest embryos or oocytes from the same donor mare identified in this contract, the new mare/owner must enter a 2022 recipient mare contract with PSMFC.

**PSMFC does not have a contingency against recipient mare contracts and the funds received for each contract upon the donor mare is harvested or oocytes are prepared or a shipped embryo is transferred. There will be no refunding of fees.**

- 1a. Recipient Lease Fee for each program recipient mare is two thousand seven hundred dollars (\$2,700.00).



To issue all recipient mare contracts received an address from the recipient mare and an agreement program at 21 days gestation.

- 1. **Notice** The mare fee will be refunded a full year amount of a written statement from the attending veterinarian stating the mare is the mare, and the mare of the recipient mare to the PSMC. If the recipient mare shows evidence that she is pregnant (PSMC) will grant a credit of \$1,000.00 toward a program recipient mare for the following year.
- 2. To pay \$200.00 per day toward all fees associated with routine care of the recipient mare after she is diagnosed as pregnant at 21 days gestation and an address location has been found including any required administration through 21 days gestation. At PSMC we firmly believe that 21 recipients are an entity in that at 21 days of pregnancy, all of them and are ready to ship home. If you choose, your recipient mare may be housed and cared for at PSMC for an additional fee. Please contact PSMC for additional information.
- 3. If at any time PSMC determines, in its sole judgment and discretion, that the Recipient Mare needs to be transferred to Peterson Smith for medical or surgical treatment, the Mare is responsible for all charges. PSMC
